#### NATIONAL SCHOOL LUNCH PROGRAM

Our lunch program offers a variety of hot and cold entrées, along with fresh fruit and vegetables. Lunch includes an entrée of lean protein and whole grains, 2 servings of fruit, 2 servings of vegetables, and 1% white or skim

#### SCHOOL BREAKFAST PROGRAM

Some Elementary schools have a breakfast kiosk service which allows students to take breakfast to their classrooms, while some Elementary and all Middle and High school students will come through the serving line in the cafeteria.

Breakfast includes an entrée with whole grains and/or lean protein, fruit, 100% juice, and 1% white or skim chocolate milk.
