Academic Recovery Plan

For the 2022–2023 school year, all districts are required to submit an Academic Recovery Plan to the South Carolina Department of Education detailing goals and strategies for providing annual growth in English language arts and math. Districts also have the opportunity to add other relevant goals to their recovery plans. Lexington District One's Academic Recovery Plan was submitted this week. The plan is aligned with our near-term priorities 2 and 3 and the associated deliverables.

SCALE Up Afterschool

We are excited to share that teaching and learning director, Dr. Erica Bissell, and early childhood and Title I coordinator, Jessica Buzhardt, have both been accepted as SCALE Fellows. SCALE, which stands for South Carolina Afterschool Leaders Empowered, is an opportunity through The Riley Institute at Furman University for educators to come together throughout the spring, summer, and fall to engage in learning around high-quality and impactful extended day and extended year programs. Erica and Jessica were chosen from a pool of applicants based on their enthusiasm, ability to impact change in the Lexington One community, and readiness to grow as leaders in the field of afterschool and summer learning.

OPERATIONS

Elementary School #19

We wanted to respond to a question received regarding the budget increase with ES19 and how it compares to other districts.

This is hard to quantify because school districts take a variety of approaches when it comes to developing budgets and capturing costs. Examples:

- 1) IT costs. Some districts do not include IT costs in their construction budgets (cabling, PA systems, classroom technology, radio repeater systems, cameras, theatrical equipment, secured access controls, etc.) while Lexington One does.
- 2) Other budget items that other districts may pay for outside of the construction budget include playground equipment, digital signage, and landscaping. If a district tells you their project came in at \$300 a square foot but none of the costs are captured in that number, then their total cost would be higher.
- 3) Another reason comparable numbers are difficult to ascertain is that site work costs are unique to the project.
- 4) Finally, districts take different approaches to the amount of money included in the project for contingency. The funds in the project allotted for unforeseen items can range from 3% to 6%.

We typically base comparisons on square footage.
