# **BOARD RECAP** — April 26, 2022 Meeting

On Tuesday, April 26, 2022, the Lexington County School District One Board of Trustees held a board meeting in Building One of Central Services' auditorium located at 100 Tarrar Springs Road in Lexington, South Carolina.

The meeting opened at 5:00 p.m. in the auditorium. The board promptly voted to enter executive session to consider employment recommendations for the 2021–2022 and 2022–2023 academic school years, to discuss proposed property contractual arrangements for the purchase of land for a new River Bluff area elementary school and to discuss and receive legal advice related to the departure of the superintendent.

The Board of Trustees resumed the public portion of its meeting after executive session at 6:04 p.m.
