Funded projects provide students with new materials such as a 3D printer to enhance science and mathematics classes at DES, Boogie Board writing tablets at GPS, high-interest texts for struggling readers at PES and mathematics puzzle games at SGES.

At LHS, donors made it possible for Crowley to purchase fluorescent light covers to soften the harsh glare of classroom lights, creating a calm environment for students with sensory issues.

## Walmart Foundation grants support literacy and outdoor fun

Students at Gilbert Middle and Pleasant Hill Elementary will benefit from projects funded by two Walmart Foundation Community Grants.

GMS Mathematics Teacher Elaine B. Rej applied for a \$250 grant to begin construction on a 9-hole disc golf course. The grant provides seed money to purchase cement and tee markers.

Rej plans to seek additional funding to complete the project, giving students the opportunity to stay active while learning a new game.

At PHES, Second-Grade Teacher Debra A. Crews received a \$500 grant for “Cougar Collections: Parent Helper Packs.” This project provides collections of leveled reading books for checkout in the library.

Each collection contains four to five books of a similar reading level, as well as detailed information for parents about their student’s skill level and the instruction they receive. Each bag includes questions for parents to use to facilitate discussion and to help grow their student’s comprehension.

Any teacher may check out the Parent Helper Packs, enabling all grade levels to benefit from the project.



## WKHS takes green steps with recycling grant

White Knoll High Science Teacher David R. Cann received a \$1,500 Recycling Education Grant to help the large school reduce its environmental footprint.

Cann applied for the South Carolina Department of Health and Environmental Control grant in order to purchase additional recycling bins.

Once a week, students from the Environmental Science class take bins throughout the school to collect recyclable materials. After they sort the paper and plastic, Cann carries the bins to the local landfill for processing.

The recycling efforts fulfill a requirement of the Green Steps Schools program, allowing WKHS to reapply for distinction as an S.C. Green Steps School.
